The charitable sector's year in numbers 2024/2025

This report provides a high-level overview of New Zealand's charitable sector for the 2024/2025 period. It draws on data reported by registered charities to highlight the sector's size, areas of activities and financial profile.

Sector overview

As at 2024/2025:

- ▶ There are **29,208 registered charities** in New Zealand.
- ▶ 122,608 charity officers are involved in the governance and running of their charities.
- ▶ 170,000 volunteers contribute approximately 1.4 million hours of their time each week.
- ▶ The sector employs over **105,000 full-time staff**, representing around **4**% of the national workforce.

These figures reflect the significant role the charitable sector plays in both community life and the broader economy.

Distribution of charities operating across New Zealand

Charities operate across all regions of New Zealand. The distribution highlights the sector's broad reach and its presence in both urban and regional communities.
